It is for the information of all the eligible candidates desirous of seeking admissions to Nursing (**Irregular Batch**), Physiotherapy and Paramedical courses in Government and Private Institutions affiliated to Pt. BD Sharma UHS Rohtak located in the State of Haryana and all the concerned that the **EXTENDED STRAY ROUND-II (OFFLINE)** of Counselling for admission to UG/PG Nursing/ Physiotherapy/Paramedical degree courses based on the merit of CET-2023 conducted by Pt. BD Sharma UHS, Rohtak shall be held as per the following schedule:

Note:-

1. The candidates must bring all relevant original documents at the time of counselling for Extended Stray Round-II (Offline), failing which their candidature shall not be considered.
2. Personal appearance must be ensured by the candidate failing which their candidature shall not be considered.
3. The candidates who have been found eligible after successful document verification in Extended Stray Round-I (Offline) of counselling but did not join to the opted college, shall not be eligible to participate in the Extended Stray round-II (Offline).
4. The candidates who have joined on the allotted seats upto Extended Stray Round-I of counselling and even “**resigned**” from allotted/opted seat shall not be eligible to participate in Extended Stray Round-II (Offline).
5. Shifting from one college to another college and one course to another course is not allowed in Extended Stray round-II (Offline) of counselling.
6. Other terms and conditions remains the same as in **Government of Haryana Notification dated 01.06.2023** and public notices issued from time to time.
7. Candidates after successful physical verification of documents will be considered as “**joined**” to allotted colleges.
8. **The candidate will have to deposit the provisional tuition fee at the time of physical verification of documents in the shape of Demand Draft drawn in favour of “Counselling and Admission on A/c for DMER” payable at Sampla (Rohtak), Bank ICICI Bank Ltd. Candidate who fails to deposit provisional tuition fee even on spot will not be considered. Candidates are advised to get prepared multiple Demand Drafts.**
