Admission to UG (MBBS/BDS) Courses in Government/Government Aided/ Private Unaided Medical/Dental Colleges including those under Private Universities –SGT University, Budhera, Gurugram, PDM University, Bahadurgh, Jhajjar and Al-Falah University, Dhauj, Faridabad in the State of Haryana for the Academic Session 2022-23.

It is for the information of all the eligible candidates desirous of seeking admission to UG (MBBS/BDS) Courses in Government/Government Aided/ Private Unaided Medical/Dental Colleges including those under Private Universities for the academic session 2022-23, fresh candidates can register for Second Round of counseling. The tentative schedule for 2<sup>nd</sup> round of counseling is as under –

**Note:-**

- The candidates, who have already registered themselves for the first round and wish to participate in the second round, shall not be required to register again.
- The candidates, who have been allotted seats in the first round of counseling shall have to give their willingness/option to upgrade themselves in the second round of counseling online otherwise they shall not be considered eligible for the second round of counseling.
- The Candidates, who have joined on the allotted seat in the first round shall have a right to already allotted seat and this shall be changed only if, he/she gets an upgraded opted seat during second round. However, **the candidates who wish to participate in the 2<sup>nd</sup> round of online counseling will have to submit their preferences/choices afresh. Candidates, who have been allotted, seat in first round should give the fresh choices in order of preferences for the seats in which they wish to upgrade themselves.**
- All candidates {already registered (irrespective of their admission status) and freshly registered candidates} who wish to participate in the second round of counseling and want to opt for State Quota Seats in only

an amount of Rs. 10,000/- (Rs. 5000/- for SC/BC/EWS/PWBD of Haryana State) and if the candidate wishes to also opt for State Quota Seats/Management Quota Seats in Private Medical/Dental Colleges including Private Universities the he/she shall have to deposit online an amount of Rs. 1.00 Lakh. This facility shall be available in the login ID of the candidates on admission web portal.

**In case of failure of any registered candidate (whether freshly registered or the candidates who were allotted seats in the 1<sup>st</sup> round and want to upgrade their seat in the 2<sup>nd</sup> round) to deposit the requisite security amount (through admission web portal only), they will NOT be considered eligible to participate in the 2<sup>nd</sup> round of counseling.**

- In case of candidates join on the allotted seat, this amount shall be adjusted in the tuition fee of the first year of UG Course.
- If the candidates are allotted any seat as per their preference, but they do not join on the allotted seat, the security amount shall be forfeited. However, these candidates will be eligible to participate in the Mop-up round after forfeiture of security amount.
- The Security amount of the candidates who are not allotted seats during the 2<sup>nd</sup> round shall be returned after the completion of the counseling process.
- The candidates who join on the allotted seats in the 2<sup>nd</sup> round of counseling, will not be eligible to participate for further rounds of counseling.
- Those who are declared INELIGIBLE after allocation seat due to deficiency of documents, the security amount of such candidates shall also be forfeited.
- Any candidate who had joined in Round-1 but do not participate in Round-2 counseling or do not resign from the round-1 allotted seats, will also be not allowed to participate in Mop-up round counseling/further rounds if any.
- The candidates who join the seat allotted to them during the All India Quota/Any State quota upto 2<sup>nd</sup> Round of counseling shall not be eligible to participate in the further round of counselling. The candidates will have to give any undertaking regarding the same.
- **Schedule may be change as per directions of Hon'ble Supreme Court/ Govt. of India/ Govt. of Haryana/MCC etc., information of which will be displayed on Admission Web portal from time to time.**

**Note: -**

- The choices filled by the candidates for the first round of counseling shall be treated as null and void and the candidates will have to fill fresh choices
- The above instructions should be read in accordance with NEET UG information bulletin 2022 and Govt. of Haryana notification dated 12.10.2022 (substituted bearing same date & No.) published on 07.11.2022 available on the Admission Web Portal and public notices issued time to time.
